In a case like this, where the defendants' actions were "part of a single overarching scheme to defraud... [,] the fact that each was aided by the other in the execution of the scheme [is] an insignificant aspect of the single plan." United States v. Benmuhar, 658 F.2d 14, 16 (1st Cir.1981) (intertwined activity exception inapplicable to mail fraud prosecution). The trial court did not err in refusing to give the instructions appellants proposed. 2. The Cross-Examination of the Witness Moll 12 Prior to trial, Jack Moll, a co-defendant who had pled guilty, signed a statement detailing his dealings with the appellants and their codefendants. At the trial, the government's position was that Moll would not testify against appellants because he had entered into a plea bargain in which he had agreed to cooperate with the United States and the federal government had agreed not to prosecute him for other illegal activities in exchange for his assistance. Before cross-examining Moll, the defense counsel informed the trial court of their belief that Moll would not testify in accordance with his plea bargain because the federal government was also prosecuting his wife, who was charged with the same crimes as Moll, and Moll's wife would not be entitled to immunity if Moll did not testify. The trial court excused Moll from testifying. 13 On appeal, appellants argue that they should have been allowed to cross-examine Moll regarding the circumstances surrounding his wife's prosecution and to compel his testimony that he agreed not to cooperate because of the threat of prosecution to his wife. Appellants, however, did not inform the trial court of their intentions to cross-examine Moll regarding his wife's prosecution or to show that M
